

Terms and Conditions for I Love Science (\$1000 Amazon Gift Card)

1. About this Promotion

- 1.1 This Promotion is offered by ADI Instruments NZ Limited ("ADI").
 - 1.2 This Promotion will begin on the 1st of September 2025 and conclude on 1st July 2026 ("Promotion Period").
 - 1.3 Subject to eligibility in accordance with these terms and conditions, participants at Conferences that ADI attend over the Promotion Period ("Conference Attendees") are eligible to enter the draw to win ("Promotion") one Amazon gift card valued at \$1,000 ("Prize").
 - 1.4 The Promotion applies to conferences, workshops, and other in person events where ADI is in attendance and displaying a Do you Love Science? poster ("Poster") at their booth with a QR Code that links to a form to fill in ("Form") and has these terms and conditions attached ("Conferences").

2. Who is eligible?

- 2.1 This Promotion is open to all Conference Attendees during the Promotion Period that qualify in accordance with clause 2.2.
 - 2.2 To qualify for this Promotion, you must:
 - 2.2.1 be a Conference Attendees that attends a Conference during the Promotion Period; and
 - 2.2.2 fill in the Form relating to this Promotion.

3. How to enter?

- 3.1 In accordance with clause 2.2.2, you must fill out the Form relating to this Promotion. To get to this Form you must scan the QR Code on the Poster at a Conference and provide the relevant information.
 - 3.2 The information collected is the following:
 - 3.2.1 email address;
 - 3.2.2 first name;
 - 3.2.3 last name;
 - any research applications you are interested in;
 - 3.2.4 confirmation that you have read and understood ADI's privacy policy;
 - 3.2.5 confirmation that you understand you are signing up for marketing emails, that you can unsubscribe to at any point; and
 - 3.2.6 confirmation that you have read and understood these terms and conditions.

4. What is the benefit of the Promotion?

- 4.1 Conference Attendees that complete clause 3 go in the draw to win the Prize.
- 4.2 There is one Prize available and all Conference Attendees that enter are equally eligible.
- 4.3 The currency of the \$1000 Amazon gift card will depend on where the Conference was that the Conference Attendee entered the Promotion. To clarify, if the Conference Attendee entered this Promotion at a New Zealand Conference and won the Prize, then they would receive an Amazon gift card worth NZD \$1,000. Whereas if the Conference Attendee entered this Promotion at an American Conference and won the Prize, then they would get a USD \$1,000 Amazon gift card.

5. How the Winner will be selected?

- 5.1 At the end of the Promotion Period, the Prize will be drawn.
 - 5.2 All Conference Attendees that have entered this Promotion will be on a spreadsheet with a number associated with them.
 - 5.3 A random number generator will be used to select which number has won and then this will be tracked back to the spreadsheet to see which Conference Attendee that entered this Promotion is attached to said number ("Winner").
 - 5.4 The Winner will be randomly drawn by ADI's Legal Department, and they will then be contacted via the information given in clause 3.2. The Winner will have two weeks to reply to ADI and if they do not get back in touch with ADI, there will be a re-draw.
 - 5.5 ADI will be responsible for getting the Prize to the Winner in the best way possible to the Winner.

6. Restrictions

- 6.1 Only one entry is allowed per Conference Attendee.
 - 6.2 ADI may be at conferences but if it is not a Conference where this competition is running, then this Promotion cannot be entered.

 - 7.2 There is no obligation on Conference Attendees or the Winner to purchase anything with ADI or be a current or future customer.
